Unit mounted on the inside of the header. Top of hood and the bottom of the hem bar to be centered from the top and bottom of the header. Width centered between rock pillar and wall of the home. Using 2" spacers to miss bolt & nuts on the header. Wrap the electrical cords in brown. Plug into the outlet that will be installed by customer on the upper deck area. Wind sensor install up onto the eve and close to the roof line above the decorative header on the north end of the upper deck. Tac the cord along edges of header and corners of the wall as smooth as possible.
