- 2. CHANGES in the above order will only be made after customer approval of any changes, including any related additional costs.
- 3. FULL PAYMENT is due upon delivery.
- 4. RETURNED CHECK charge is \$20.00 plus costs of collection.
- 5. PAYMENT AND PRE-PAYMENTS are non-refundable. No returns on custom orders.
- 6. WE CLAIM A LIEN on all property until services are paid in full, and may retain possession of any property upon which we have performed labor until full payment, including interest and storage charges have been made.
- 7. STORAGE FEES may be charged for any property not claimed and paid for within 30 days after completion of work.
- 8. PROPERTY MAY BE SOLD IF not claimed within 45 days, or if it is held by us more than 45 days due to customers failure to pay all amounts due. Proceeds will be applied to amounts due. We retain the right after sale to sue for any remaining amounts owed.
- 9. COLLECTION COSTS: I agree to pay all attorney's fees, court costs, filing fees and collection costs. Up to 50% of the amount owing may be added as a cost of collection.
