- FULL PAYMENT is due upon delivery.
- RETURNED CHECK charge is \$20.00 plus costs of collection.

- WE CLAIM A LIEN on all property until services are paid in full, and may retain possession of any property upon which we have performed labor until full payment, including interest and storage charges have been made.
