3. FULL PAYMENT is due upon delivery.
4. RETURNED CHECK charge is \$20.00 plus costs of collection.
5. PAYMENT AND PRE-PAYMENTS are non-refundable. No returns on custom orders.
6. WE CLAIM A LIEN on all property until services are paid in full, and may retain possession of any property upon which we have performed labor until full payment, including interest and storage charges have been made.
7. STORAGE FEES may be charged for any property not claimed and paid for within 30 days after completion of work.
